Born in Italy and immigrated to Canada in 1977, Federica Nazzani is a testament to entrepreneurial spirit. As a Chartered Accountant and Chartered Business Valuator, she has held senior positions in the litigation and valuation practice of leading firms, Deloitte (predecessor, Arthur Andersen) and LECG, providing expertise in business valuation, contract negotiations, financial investigation and economic damage quantification for complex litigation and transactions to the legal and business communities and to the Government. At an early stage in her career, Federica aspired to create her own consulting company and co-founded Capital Assist Inc. in 2000, a professional services company in the area of litigation support, valuation, and transaction support services to businesses. While still actively involved with her company in Toronto,

Federica took on a new role in her family's real estate development company in early 2003, returning to Windsor as Vice-President of Finance of Prime Rose Inc., an owner and manager of commercial real estate properties. Her responsibilities included the overall administration of the organization's operations and its financial management, specifically oversight of the facilities management, budgeting and finance, and marketing aspects of the business. In October 2006, Federica led the strategic sale of its principal real estate portfolio to a Toronto based investment firm and in April 2007, was appointed as a Senior Advisor in Strategic Planning and Infrastructure for the Mayor of the City of Windsor. Most recently, Federica accepted the position of General Manager of the Windsor Airport, which is currently operated by a public corporation, Your Quick Gateway (Windsor) Inc.

Federica has actively contributed to the community with enthusiasm and dedication. Her volunteer involvement in Windsor includes serving as a member of the Board of Directors, Governance Committee for the Windsor Family Credit Union and as a member of Board of Directors of Enwin Energy. Up until this year, she was the former Chair of the Finance and Tax Committee and Director of the Board for the Windsor & Essex Regional Chamber of Commerce. Until 2007, she was a Commissioner for the Windsor Utilities Commission Board of Directors, Vice Chair of the Audit Committee for the City of Windsor, and former Vice Chair and Treasurer of the Women's Economic Forum. She is a former Alumni Representative for Masters of Accountancy Class of 1995, University of Waterloo Fundraising Committee and has been a Tax Clinic Volunteer for the Institute of Chartered Accountants of Ontario for the past 10 years.

Federica received the designation of Chartered Accountant (1995) and Chartered Business Valuator (1997) and has an Honours Bachelor of Arts in Chartered Accountancy Studies and a Masters of Accountancy from the University of Waterloo. She has lectured for the Ontario Institute of Chartered Accountants on professional development in business valuation and was a senior marker for the membership entrance examinations of the Canadian Institute of Chartered Business Valuators. She enjoys spending time with friends, tennis, golf and travel.
